CCIC in partnership with the Colorado Immunization Program and the Vaccine Advisory Committee for Colorado created and manages the "Immunize for Good" campaign, which addresses parent's concerns about vaccination and provides credible information about the importance and safety of children's immunizations. Additionally, we offer education and resources through brochures, postcards, posters, community events, and social media platforms.
