4b (Code:) (Expenses \$ 196,818. including grants of \$) (Revenue \$) Community Outreach: CCIC offers the public credible and timely information in vaccination through educational materials and outreach campaigns. CCIC in partnership with the Colorado Immunization Program and the Vaccine Advisory Committee for Colorado created and manages the "Immunize for Good" campaign, which addresses parent's concerns about vaccination and provides credible information about the importance and safety of children's immunizations. Additionally, we offer education and resources through brochures, postcards, posters, community events, and social media platforms.

4c (Code:) (Expenses \$ 26,088. including grants of \$) (Revenue \$) Provider Education: CCIC serves the provider population with educational opportunities tailored to the needs of those involved in the access and delivery of vaccines across the State. Education is offered on-line through monthly webinars and through live seminars to provider offices, local public health agencies and local coalitions. Educational seminars are led by context experts from the CCIC Board of Directors, Children's Hospital Colorado and the Colorado Department of Public Health and Environment.
